ANNOUNCEMENT OF OFFER PRICE AND ALLOTMENT RESULTS

SUMMARY

Offer Price and Net Proceeds from the Share Offer

- The final Offer Price has been determined at HK\$1.2 per Offer Share plus brokerage of 1%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%.
- Based on the final Offer Price of HK\$1.2 per Offer Share and 67,500,000 Shares offered by the Company, the net proceeds from the Share Offer, after deducting the underwriting commissions and other expenses in connection with the Share Offer, is estimated to be approximately HK\$59.6 million. The Company intends to apply such net proceeds in accordance with the purposes set out in the section headed “Future plans and use of proceeds” in the Prospectus.

Applications under the Public Offer

- The Public Offer Shares initially offered under the Public Offer have been very significantly over-subscribed. A total of 143,001 valid applications were received pursuant to the Public Offer on **WHITE** and **YELLOW** Application Forms, through giving **electronic application instructions** to HKSCC via CCASS and through the **eWhite Form** Service Provider under the **eWhite Form** service for a total of 42,451,304,000 Public Offer Shares, representing approximately 6,289 times of the total number of 6,750,000 Public Offer Shares initially available for subscription under the Public Offer.
- Due to the very significant over-subscription in the Public Offer, the reallocation procedures as described in the section headed “Structure and conditions of the Share Offer – The Public Offer – Reallocation” in the Prospectus have been applied. As the number of the Public Offer Shares validly applied for in the Public Offer represents more than 100 times of the total number of the Public Offer Shares initially available under the Public Offer, 27,000,000 Offer Shares have been reallocated from the Placing to the Public Offer. As a result of such reallocation, the final number of Offer Shares allocated to the Public Offer has been increased to 33,750,000 Offer Shares, representing 50% of the total number of Offer Shares available under the Share Offer, and being allocated to 13,560 successful applicants under the Public Offer.
